### O'Connor leaves a legacy of transit

Pam O'Connor sought to make Santa Monica more connected with the rest of Southern California during her 24 years on City Council.

The council honored O'Connor, who lost her seat in the Nov. 6 election, at its meeting Tuesday.

Councilmembers remembered her for her commitment to transportationand sustainability, perhaps best exemplified by her championing the expansion of the Expo Line to Santa Monica while a member of LA Metro's Board of Directors. The board initially intended the line to terminate in Venice, but O'Connor successfully argued it should run to Santa Monica.

O'Connor said her involvement in Metro, the Southern California Association of Governments (SCAG) and other regional organizations enabled her to bring needed change to Santa Monica and Southern California - something she thinks future councilmembers should remember as they try to create policy that will benefit the city.

"You help your city when you're working regionally," she said. "Somebody from another city may not have articulated their support for the Expo Line in the manner I did while I served on Metro's board ... but I took every opportunity I could to move that project forward."

### All Malibu schools open after fire, extensive testing

After a long and arduous road recovering from the Woolsey Fire, Malibu residents are adjusting to a life back in their communities and safe spaces, students included.

### Rep. Pelosi: 4-year maximum in speaker post is 'a long time'

Rep. Nancy Pelosi shrugged off suggestions Thursday that she weakened herself by agreeing to limit her tenure as next House speaker to a four-year maximum in a deal that clears the way for her to be elected to the post for the new

"That's a long time," she said at a news conference a day after she and seven insurgents who'd been pushing for younger leadership announced their pact.

For weeks, the 78-year-old California Democrat had resisted opponents' demands that she step aside or restrict how long she'd serve, saying limits would make her a lame duck and sap her bargaining clout. But on Wednesday, she relented and struck a deal that all but guarantees she'll be elected when the House votes on its new speaker on Jan. 3.

"What, four years? No, I don't think that's a lame duck," she told a group of reporters afterward.

Democrats widely agreed that the pledge meant Pelosi had clinched a comeback to the post she held from 2007 until January 2011, the last time her party ran the House and the first time the speaker was a woman.

Wednesday's accord gives Pelosi a clear path to becoming the most powerful Democrat in government and a leading role in confronting President Donald Trump during the upcoming 2020 presidential and congressional campaigns. It moves her to the cusp of steering next year's diverse crop of House Democrats, with its large number of female, minority and younger



### Santa Monica City Attorney's Office Obtains **Judgment Against Tenant In Rental Scam Case**

The Santa Monica City Attorney's Office has reached a final settlement with local resident Patricia Anglano in a lawsuit filed by the City accusing Anglano of harassing multiple sub-tenants and potential renters, and taking money from them under false pretenses.

The lawsuit, filed in Santa Monica Superior Court earlier this year, alleged that Anglano engaged in an elaborate scam against more than ten people who responded to online ads to rent a room in her Santa Monica apartment. According to the City's complaint, Anglano first extracted money from applicants for the room, and then, once their checks were deposited, subjected them to bizarre and harassing behavior designed to make them flee the apartment or never move in at all.

### THIS ALLEGED BEHAVIOR INCLUDED:

- threatening applicants with bodily harm
- making false accusations to the police and the applicants' employers
- invading applicants' privacy
- taking away use of the kitchen, living area, or other amenities
- warning applicants not to tell anyone about the rental
- demanding that applicants immediately vacate the apartment

The Santa Monica City Attorney's Office filed the case under the City's Tenant Harassment law, which prohibits a range of unlawful behavior by landlords against tenants - including in cases, such as this one, where tenants harass sub-tenants.

Under the terms of the settlement, which was entered as a Final Judgment by the Superior Court, Anglano will be prohibited from ever advertising or renting out a rental unit, room, or other residential space to another person again in the City of Santa Monica. Anglano is also barred from receiving any money for such rentals.

"This is a fair settlement," said Santa Monica Chief Deputy City Attorney Adam Radinsky who heads the City's Consumer Protection Division. "Our first job is always to protect the public from unfair and unlawful behavior. This Judgment against Patricia Anglano serves that

### Where There's "Smock" There's Fire

The agreement also ends what's been a distracting, harsh leadership fight among Democrats that has been waged since Election Day, when they gained at least 39 seats and grabbed House control for the next Congress. It was their biggest gain of House seats since the 1974 post-Watergate

To line up support, Pelosi initially resorted to full-court lobbying by congressional allies, outside Democratic luminaries, and liberal and labor organizations. She cut deals with individual lawmakers for committee assignments and roles leading legislative efforts.

But in the end, she had to make concessions about her tenure to make sure she'll win a majority — likely 218 votes — when the new House votes. Democrats are likely to have 235 seats, meaning she could spare only 17 defections and still prevail if, as expected, Republicans all oppose her.

Rep. Ed Perlmutter, D-Colo., a dissident and friend of Pelosi's, said the two began seeking middle ground after she called him around Thanksgiving. He told reporters that the two spoke a dozen times before the agreement was reached.

"I think the change has started," Perlmutter told reporters. He said that, meanwhile, Democrats have a leader "who's going to be really good at the helm during some tumultuous times."

Rep. Linda Sanchez, D-Calif., another lawmaker who wanted fresh leadership, said no one wanted to directly challenge Pelosi because "she's tough, she's good, she's a woman, she's done it before." Sanchez said Pelosi has led Democrats so long that "it's sort of ingrained" and "it's hard to overcome that."

Under the deal, House Democrats will vote by Feb. 15 to change party rules to limit their top three leaders to no more than four two-year terms, including time they've already spent in those jobs. There is no guarantee that Democrats will formally approve the plan, but Pelosi embraced it anyway.

"I am comfortable with the proposal

and it is my intention to abide by it whether it passes or not," Pelosi said in her statement.

Pelosi's opponents have argued it was time for younger leaders to command the party. They also said her demonization as an out-of-touch radical in tens of millions of dollars' worth of Republican television ads was costing Democrats seats.

While some Democrats are still certain to vote against Pelosi — including incoming freshmen who promised to do so during their campaigns — most Democrats have remained solidly behind her. She's been a strong fundraiser and unrelenting liberal who doesn't shy from political combat, and her backers complained that her opponents were mostly white men who were largely more moderate than most House Democrats.

Pressure to back Pelosi seemed to grow after she calmly went toe-to-toe with Trump at a nationally televised verbal brawl in the Oval Office on Tuesday over his demands for congressional approval of \$5 billion for his proposed border wall with Mexico.

"We are proud that our agreement will make lasting institutional change that will strengthen our caucus and will help develop the next generation of Democratic leaders," the rebellious lawmakers said in a written statement.

To be nominated to a fourth term under the agreement, Pelosi would need to garner a two-thirds majority of House Democrats. Several aides said they believed restlessness by younger members to move up in leadership would make that difficult for her to achieve.

The limits would also apply to Pelosi's top lieutenants, No. 2 leader Steny Hoyer of Maryland and No. 3 leader James Clyburn of South Carolina. Both are also in their late 70s.

Perlmutter was among 16 Democrats who had signed a letter demanding new leadership but who ultimately helped negotiate the deal with Pelosi.

Joining Perlmutter in saying they would now back her were Democratic Reps. Seth Moulton of Massachusetts; Tim Ryan of Ohio; Bill Foster of Illinois; Sanchez and Rep.-elect Gil Cisernos, both of California; and Filemon Vela of Texas.



O'CONNOR

The 12-year term limits voters approved in November presents a challenge for councilmembers looking to get involved and move up the ranks of regional organizations, she said. O'Connor was in her seventh year on the council when she got a seat on Metro's board after serving for a few years on SCAG's transportation committee.

"Completion (of the Expo Line) took 10 years, not to mention the planning process before," she said. "The thing about term limits is we've limited the ability of future councilmembers to take on leadership roles throughout the region. If they want to do it, they have to jump in early, be a little lucky and get in when a leadership position is open"

Councilmembers said at Tuesday's meeting that O'Connor, who also served as Mayor of Santa Monica in three different decades, was a pioneer of sustainable transportation at the local, regional and statewide level.

"We all know Pam as a powerful advocate on ... sustainability before the idea had really gained maturity," said Mayor Pro Tempore Terry O'Day.

Mayor Gleam Davis said the city and the region have O'Connor to thank for new and better mobility options, including bicycle lanes and improvements to the Big Blue Bus.

"She was the one who understood that if the LA region was going to be sustainable in 2050, we needed to start building toward that now," Davis said.

O'Connor said she hopes the council will commit to sustainability and embrace the idea that Santa Monica must change over time. She believes sustainability and housing – which necessitates new development – are closely connected, but the council hasn't always understood that.

For example, councilmembers decided to limit density in transit-rich corridors of the city while creating the Land Use and Circulation Element (LUCE), which she said has ramifications for both housing affordability and sustainability.

"Refusing to build more near public transportation is really impeding our ability to reduce greenhouse gas emissions," she said. "Councilmembers have been intimidated by those voices that don't want more housing, but millennials are adults or becoming adults and need to be housed."

O'Connor will continue promoting sustainability on Metrolink's Board of Directors and the California Transportation Commission, and she hopes the council does the same.

"Will they be bold enough to do build more housing, to try something new, or be scared and intimidated by voices who bury their heads in the sand and think the world won't change if they can stop things?" she said. "The reality is the world will change, and if the City isn't willing to experiment and have a role in creating it, it will be forced upon them in unanticipated ways."

High School were all tested. Malibu and Cabrillo were tested for PCBs due to known or assumed PCBs at those sites. Malibu and Cabrillo contain a healthy level by EPA standards, with PCB levels not detected above the laboratory reporting limit.

Drati says the district will continue keeping up with a district-standard for cleaning as well as monitoring air quality and the accumulation of dust and particles.

"These reports are more exhaustive than

what other school districts have done in terms of testing following a fire event," Dr. Drati said in the letter. "We did this based on parent and staff feedback we received and we appreciate your patience while additional days were needed to accomplish this."







### US traces lettuce outbreak to at least 1 California farm

U.S. health officials have traced a dangerous bacterial outbreak in romaine lettuce to at least one farm in central California.

Food regulators said Thursday that other farms are likely involved in the E. coli outbreak and consumers should continue checking the label before purchasing romaine lettuce.

The Food and Drug Administration said 59 people have now been sickened by the tainted lettuce. Officials said a water reservoir at Adams Brothers Farms in Santa Barbara County tested positive for the bacterial strain and the owners are cooperating with U.S. officials.

The government also narrowed the source of the outbreak to three California counties: Santa Barbara, Monterey and San Benito. The FDA said lettuce from other areas harvested after November 23 should be safe to eat.

### Facebook hosts offline privacy 'pop-up' in New York City

Wrapping up a year of privacy scandals and a host of other problems, Facebook hosted a one-day "pop-up" event in New York City's Bryant Park on Thursday, hoping to talk to users about their privacy settings, ad preferences and whatever else may be on their mind.

Amid the park's holiday market, food stalls and a busy ice skating rink, the company set up a trailer to lure in passers-by from the cold with hot chocolate.

Facebook's chief privacy officer, Erin Egan, acknowledged that only a few of Facebook's more than 2 billion users are likely to stop by. But she says the hope is that those who do will "teach others" about what they learn there.

Facebook has held similar events in Dubai, Dublin and London.

### US appeals court blocks Trump birth control coverage rules

A U.S. appeals court Thursday blocked rules by the Trump administration allowing more employers to opt out of providing women with no-cost birth control.

States were likely to succeed on their claim that the changes to President Barack Obama's health care law were made without required notice and public comment, a divided, three-judge panel of the 9th U.S. Circuit Court of Appeals said.

The panel upheld a preliminary injunction against the rules issued by a lower court judge last year. An email to the Justice Department seeking comment was not immediately

Obama's health care law required most companies to cover birth control at no additional cost, though it included exemptions for religious organizations. The new policy allowed more categories of employers, including publicly traded companies, to opt out of providing free contraception to women by claiming religious objections. It also allowed any company that is not publicly traded to deny coverage on moral grounds.

The Department of Justice said in court documents that the rules were about protecting a small group of "sincere religious and moral objectors" from having to violate their beliefs.

California filed a lawsuit to block the changes that was joined by Delaware, Maryland, New

California argued that the change could result in millions of women in the state losing free birth control services, leading to unintended pregnancies that would tax the state's health care and other social programs.

### Home of NFL's Chargers, MLS' Galaxy to change name in 2019

The home stadium of the NFL's Los Angeles Chargers and Major League Soccer's LA Galaxy will change its name in 2019.

StubHub Center will become Dignity Health Sports Park on Jan. 1, owner AEG announced

The two-stadium sports complex is centered on a 27,000-seat stadium that has been the home of the five-time MLS champion Galaxy since 2003. The Chargers are finishing their second of three seasons with the stadium as their temporary home after relocating north from San Diego.

The 125-acre complex includes an 8,000-seat tennis stadium that is much better known as an open-air boxing venue, along with a velodrome and training centers for the U.S. Soccer Federation and the United States Tennis Association.

The Chargers will move into a multibillion-dollar stadium complex being built in Inglewood by Rams owner Stan Kroenke in 2020, but the Carson stadium will continue to host professional football as the home of Los Angeles' team in the revamped XFL, which begins play

The stadium complex was built by sports conglomerate AEG, which also owns the Galaxy. The complex opened as Home Depot Center in 2003 and changed its name to StubHub Center in 2013.
